NETARHAT VIDYALAYA SAMITI, NETARHAT

Netarhat Vidyalaya, a Jharkhand State Government's premier Senior Secondary Residential School located on a beautiful Netarhat plateau, nearly 160 km from Ranchi, is widely known for imparting quality education and all round development of the boys for the past 64 years. This school has since been granted autonomy and is being administered by Netarhat Vidyalaya Samiti - a Society registered under the Societies Registration Act, 1860. Netarhat Vidyalaya Samiti (the Chairperson of the Samanya Nikay of which is the Hon'ble Education Minister of the Jharkhand State) proposes **to appoint Principal** for this school on contract basis, for five years.

A. The detail of Vacancy is as under:

Principal- 1 (One)

B. Age: as on 1st January 2018: **Minimum - 45 years, Maximum - 55 years** (However, attempts to amend the Niyamawali of the Samiti to enhance the maximum age to 60 years (in view of the provision in existing Niyamawali of superannuation age of 65 years for Principal) is under process. Such of the candidates who may be between 55-60 years of age may also apply without any application fee; and if the Niyamawali gets amended, they may be invited to attend the interview; under such a situation they shall be required to bring the Bank Draft of Application Fee)

- E.** (a) On the basis of qualifications and experiences, candidates will be short listed and will be called for interview.
 (b) The candidates will be selected on the basis of their qualifications, experience etc, and performance in the interview.
 (c) The incomplete/ unsigned applications and applications without certified /attested copies of requisite certificates will be rejected.
- F.** Before being appointed, he is required to appear before the Medical Board duly constituted by the Executive Committee and declared medically fit by the Board.

G. Initially the appointment will be on probation for one year. On satisfactory completion of the probation period, the contract will be extended for another four years and it may be renewed till the age of 65 years.

H. Application Fee: A Demand Draft of Rs 1000/- (One thousand) of State Bank of India in favour of the Principal, Netarhat Residential School, payable at Lohardaga.

H.
