Adoption of Statutory Audit Report for the Financial Year 2025-26.

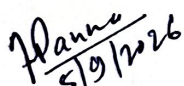

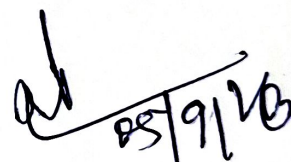
There being no other matter for consideration, the meeting concluded with a vote of thanks to the Chair .

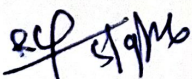

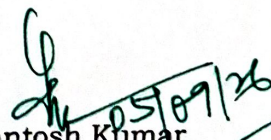
