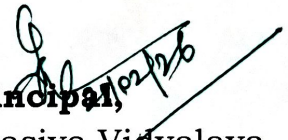
Functions of the Committee:

3. To inquire into any complaint of ragging, bullying, or fighting received verbally, in writing, or through the complaint box system.
4. To recommend suitable disciplinary action to the principal based on the findings of inquiry.

General Instructions:

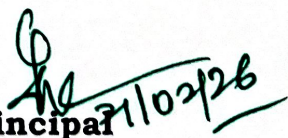
- All teaching and non-teaching staff are directed to remain vigilant and report any case of ragging or indiscipline immediately to the Committee or the Principal.

- All students are hereby strictly warned that any involvement in ragging, physical violence, or group fights will invite **strict disciplinary action**, which may include suspension or expulsion from the Vidyalaya.
- The detailed **Anti-Ragging Policy** will be displayed on all Ashrams and Vidyalaya notice boards for the information of students and staff.

This order takes effect immediately and shall remain in force until further orders.
